All available IDX property listing information is exported nightly directly from your InnoVia MLS System into a data file which is then sent to you via FTP to a location on your server. The data file contains those fields of information as determined by your board or association at the time of IDX creation and made available to you for use and inclusion within you or your firms website(s) in whatever format you choose to utilize. Your first FTP push will include a full photo file. An incremental photo file is sent each night after the first push, which includes those photos that have become available since the last data file creation cycle. A full photo file may be requested at a later date on a case-by-case basis. Set-Up Fee \$225.00 Annual Fee \$200.00
